# Measures introcuded by Government Decree 46/2020 (11.16.)

# Main measures introduced by the Decree (1/2)



Due to the unfortunate spread of the new type of coronavirus, the Government, in accordance with Government Decree 46/2020 (III.16), introduces the following measures effective from 17 March, 2020 in order to prevent and eradicate the epidemic.

### **Main measures introduced by the Government**

**Operation of stores** 

It is prohibited to stay in stores between 3 pm and 6 am, except for the employees.

However, staying in the stores for the purpose of ordering and taking away food, and for the payment of the purchase price **is allowed** for the period of time required to complete these activities.

**Exceptions**: Stores selling food, toiletries, drugstore products, household detergents, chemical products and sanitary paper products, pharmacies and stores selling medical aids, fuel stations and tobacco shops do not fall under the restrictions.

It is **forbidden** to stay at the location of regular music and dance events, or any other events and gatherings. **Sport events** may be held without spectators under closed conditions.

**Events** 

Religious ceremonies, civil marriages and funerals are not considered to be events.



# Main measures introduced by the Decree (2/2)



### **Main measures introduced by the Government**

#### **Administration**

Official documents issued by government agencies are delivered to customers only by post. Official documents may be not be available via **personal customer services**.

Government agencies provide username information to customers who already have a so-called E-Gate registration via its 1818 Governmental Customer Line.

It is **prohibited** to visit theaters, cinemas and museum institutions, including public collections, community cultural institutions, and community spaces.

Culture

Persons above the age of 70

Persons above the age of 70 are requested **not to leave** their place of residence or domicile. The mayor of the local government is responsible for providing **supply to them**.



# Compliance with the Decree, consequences



### **Compliance with the Decree**

 The compliance with the restrictive measures of the Decree will be monitored by the police.

#### Consequences

- In the event of non-compliance with the restrictive measures, the police may apply coercive measures in accordance with Act XXXIV of 1994 on the Police.
- Anyone participate or stay at the location of events covered by the Decree during an unauthorized time or in an unauthorized manner shall be deemed to have committed a minor offence.
- The lowest amount of the fine **imposed for minor offences** shall be five thousand forints, the highest amount shall be five hundred thousand forints.
